Countering marauding terrorist attacks

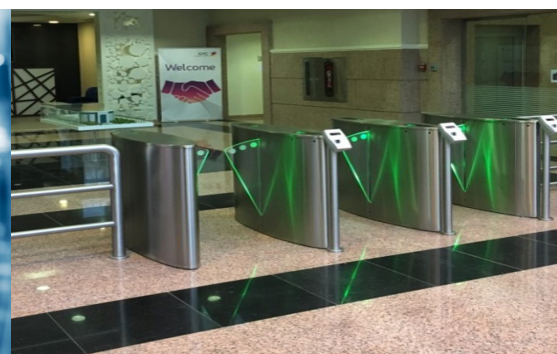

Although government and security force responses are improving, the rising number of complex attacks worldwide demonstrates the need for companies to enhance their resilience to these dynamic situations.
