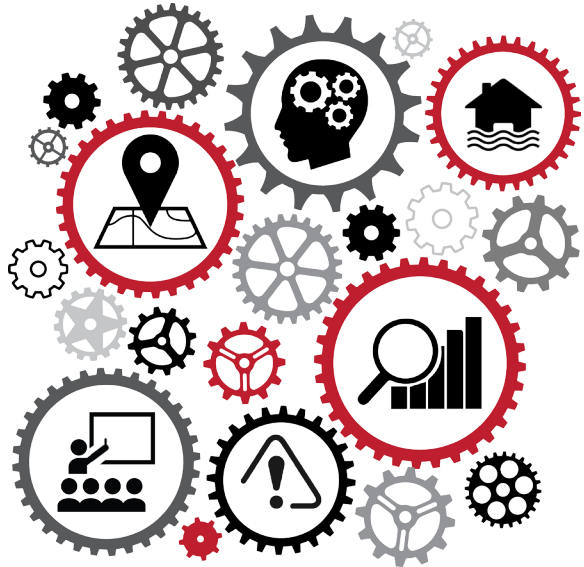

Performance Highlights

- Late on a Friday afternoon, a disgruntled customer arrived at a leading international publisher's New York City headquarters and insisted on seeing the company's CEO. When the receptionist asked the man to leave, he became aggressive and made threats against staff and the CEO before leaving the building. Concerned about the potential for violence, the company reached out to G4S. The GRIC Team responded to the threat within hours by deploying workplace violence armed protection agents to the CEO's Manhattan residence to protect him and his family. A surveillance Team was also deployed along all potential routes into the headquarters building and later, after it was determined that the individual may have flown back to his home country, surveillance agents were deployed internationally to confirm the threat had indeed abated.
- G4S was contacted to provide protection services for a major United States television network after one of its main cast members was severely injured during the filming of an award-winning prime time show. The medical incident involved a faulty set piece, which had fallen on the actor and resulted in serious head lacerations. The GRIC Team immediately orchestrated an emergency medical evacuation. The actor was transported from the remote set location via helicopter to a proper medical facility 160 miles away and accompanied throughout the entire trip and his subsequent recovery by a G4S agent.
- A large global outsourcing business had some concerns after receiving a tip that one of its employees in the Philippines was potentially involved in suspected terrorist activity and contacted G4S to conduct a covert assessment of the situation. Within minutes, the GRIC Team confirmed the individual's involvement in the Rajah Solaiman Movement (RSM) by comparing company-supplied photographs of the individual to an image found on a terrorist watch list search. Additional discussions with key FBI Counterterrorism Division contacts revealed the individual's implication in a deadly airport bombing in Cotabato City and his role in actively soliciting and funneling donations for the RSM from the Middle East to Southeast Asia. Through its rapid and professional response, G4S helped confirm the identity of an international terrorist and advised the company on proper steps to help mitigate future risk.
